Desperate Shaheen Openly Coordinating With Reid's Outside Money Group

Concord - After months of railing against outside money, an increasingly nervous Jeanne Shaheen is now openly coordinating with Senator Harry Reid's SuperPAC on ads supporting her flailing campaign. It is illegal for campaigns to coordinate messaging with SuperPACs and Shaheen's desperate move raises serious ethical and legal questions.

smoke signals to Harry Reid begging for help from his outside money SuperPAC. This is another dishonest Washington politicians like Jeanne Shaheen," said NHGOP Chairman Jennifer Horn. "Additionally, Shaheen's blatant attempt to coordinate with an outside SuperPAC is potentially illegal and raises serious ethical questions about her campaign."

Yesterday the Shaheen [campaign posted dishonest talking points](#) targeting a New Hampshire Republican senate candidate. Under the headline, "An important messages for New Hampshire," the Shaheen campaign also posted a script for an attack ad and a link to stock images of Senator Shaheen.
